



## Annual June Sports Soccer Tournament Adult Rules and Regulations

1. **Tournament is a Double Knock-out for ladies. Tournament is Round Robin for Men.**
2. Players can only play in one division ie. **16 & Under** player ineligible to play with adult team
3. If the referees find that any player is under the influence of drugs or alcohol while playing, the referee will ask the coach to remove the player from the game. This player will be automatically suspended from the tournament.
4. The use of ineligible players will result in default of the game.
5. **Players who have not signed the waiver by THEIR first game of tournament will be ineligible to play the tournament. Waivers are to in be the hands of tournament committee at least 30 minutes before the team's FIRST game. IF any players have NOT signed, they can sign the Waiver at the Namgis First Nation Technical Services Grey Van, by the Food Stalls at the Big House Field.**
6. Final line-ups in hands of tournament committee at least 30 minutes before teams FIRST game.
7. All teams must be ready to go on field immediately after the previous game. Fifteen minutes late and game is forfeited. Minimum of 8 players to start.
8. Each team will be responsible for providing a linesman for their game.
9. FIFA and CSA rules shall prevail and be strictly adhered to, except 18 player rosters, unlimited substitutions, game time halves. Games are 40 minute halves. Sundays Semi- finals and Finals are 45 minutes halves.
10. Sunday's semi-final games if tied will be determined by penalty shots. Final games follow the Golden Goal rule if tied. Two sudden death ten (10) minute halves and if game is still tied, then five (5) penalty kicks will determine winner.
11. **ALL REFEREE DECISIONS ARE FINAL.**

12. Physical/Blatant Verbal abuse of the officials from players/coaches/managers can result in expulsion from tournament.
13. Any protest of tournament regulations must be in the hands of the tournament grievance committee, in writing no later than fifteen (15 minutes) following a game in accompanied by a \$200.00 dollar cash deposit.
14. If the grievance committee finds an individual guilty of the act of causing deliberate physical injury to a player, a coach, or official during a protest. The individual will not be allowed to play, coach or manage the duration of the tournament. Grievance committee may also impose a stiffer penalty such as not being able to play, coach, or manage in all future June Sports Tournaments.
15. Any player with two yellow cards or one red card will sit out their team's following game. Any player displaying excessively violent or unsportsmanlike conduct will be suspended for the remainder of tournament.
16. It is the Teams responsibility to uphold the good sportsmanship of players/coaches/managers/fans. There will be ONE warning from the REF and if the harassment/verbal/physical abuse continues then the REF will forfeit the game. The Team/Fans that is NOT showing good sportsmanship/harassing/using foul language towards the ref or opposing team, will lose the game regardless of the score.
17. If an officiating member is harassed physically or verbally, ON or OFF the field the individual will be ejected.
