It is your responsibility to ensure that you are on the list of voters and that we have your current address. A copy of the voters list is posted in the 'Namgis Administration Office.

The following question will be asked of the Eligible Voters of Namgis First Nation by ballot:
"DO YOU APPROVE THE SALE OF 88% EQUITY IN KUTERRA AND APPROVE A LEASE FROM 'NAMGIS TO KUTERRA FOR 75 YEARS?"

If you have not previously registered you will be required to provide your Band Registry Number (Status Card), Date of Birth and an email address and phone number. If you encounter any problems or are unable to complete this registration process, contact the Ratification Officer immediately.

IF YOU HAVE PREVIOUSLY REGISTERED TO VOTE USING ONEFEATHER - YOU DO NOT NEED TO REGISTER AGAIN. YOU WILL BE SENT VOTING INSTRUCTIONS AND A SECURE LINK AUTOMATICALLY WHEN THE POLL EVENT STARTS.

All registered non-resident electors that have current address information on file will receive a voting package detailing how they can participate in the referendum. **Mail-in ballots will be accepted up to the close of the referendum voting at 9:00 PM on Tuesday - July 2, 2019.**
