- I will practice social distancing rules for 14 days prior to admission.  
- Please read "Provincial guidelines with social distancing practices" <https://www2.gov.bc.ca>
- I have done the COVID-19 Pre-screening questionnaire with my Wellness Worker and agree to re-do the questionnaire upon arrival.
- Understands and accepts that there will be
  - No weekend passes
  - No external visitors
  - Safe social distancing will be practiced in all aspects including all staff
  - Using a mask for first 14 days as directed
- Travel arrangements must be confirmed with the Intake Co-ordinator. This includes a safe escort to and from the Pt. McNeil Ferry Terminal with a guarantee that return travel is in place.

In the event of illness during treatment and if the client needs to return home immediately and needs medical follow-up, a person of support is prepared to pick them up.

- Agrees and understands while I am at NTC, I will follow COVID Guidelines of physical & social distancing, handwashing, and other guidelines as instructed by staff.



## Information

- Distancing - staying 2 meters (or 6 feet away) from other clients and staff.
  - Respecting the distancing measures in all common areas by following the limits in place.
  - Limited WiFi will be opened-up and access to phones will be permitted during the first two weeks, which will allow me to stay primarily in my room.
  - Washing my hands regularly throughout the day with warm soapy water, particularly before and after meals.
  - Avoid touching my face, sneeze or cough into my sleeve or tissue, wash hands.
  - Hygiene practices will be covered upon arrival.
  - Self-Care: Focusing on self and the things I CAN control such as washing my hands, balanced sleep, eat well  
Doing my work:
    - i) participate wholeheartedly in the program
    - ii) honor my culture and tradition
    - iii) practice prayer and meditation
    - iv) take in fresh air and exercise keeping social distance
    - v) take one day at a time.
- I agree to arrive at Port McNeil ferry terminal at a schedule time as arranged with NTC Intake Coordinator.
- Accepts that no access to Cormorant Island will be permitted for my driver and other passengers.
